I further agree that I will not make any claims against, sue, attach the property of, or prosecute Arrow's Heart Animal Rescue (or any of its volunteers) for any death, personal injury, or property damage, whatever the cause or place of the event giving rise to the claim, which I may suffer or sustain as a result of or in a connection with my participation as a volunteer. _____ (Initial)

I further understand that the behavior of domestic animals is sometimes unpredictable and that some domestic animals are capable of inflicting serious personal injury or death, as well as extensive property damage.
